5. METHODS OF EDUCATION

In the course of teaching discipline, methods should be used to:

- formation of students' interest in cognitive activity and responsibility for educational work;
- provision of intellectual activity (inductive, deductive , reproductive and exploratory);
- as well as methods related to controlling the student's educational activities.

Among the methods of teaching, in particular, the following are applicable: narrative, explanation, conversation, lecture, demonstration, observation, discussion, research projects, "business games", interactive techniques, preparation and presentation of essays.

6. METHODS OF CONTROL

Students' knowledge and skills acquired during the study course "Cooperation with the EU on Migration, Asylum and Combating Crime» are evaluated according to the rating system.

Forms of current control include: assessment of the implementation of home independent tasks, essays, written and control works performed during practical classes.

A student can receive a maximum of 50 points for oral answers or tests or tests for practical classes.

Unreadiness or unsatisfactory answer (problem solving) are also subject to appropriate evaluation and the student is awarded a "0" mark. The "0" points obtained in this case need to be worked out and the evaluation obtained during the workout is taken into account in determining the average score of current progress.

The form of current control knowledge is to perform a test work. The test work is carried out in writing and consists of theoretical questions and practical tasks and can be estimated at a maximum of 50 points. A student who did not perform a supervisory work or performed it on an unsatisfactory rating is required to perform a control work.

The form of the final control of knowledge and skills in the discipline for students is a score, which is displayed on the basis of current progress and evaluation for control work.

- **9 0-100 points (excellent)** presented to a student who gave a complete and correct answer to all questions based on knowledge of regulations, jurisprudence and special literature. Manifestations of the ability to apply acquired knowledge to specific socioeconomic situations and the ability to analyze the sources of study of this course.
- **81-89 points (very good)** presented to a student who gave a not complete but correct answer to all questions based on knowledge of the subject.
- **71-80 points (good)** presented to the student who gave the full and correct answer, but not for all questions, or the answer is not based on all the components of the study. That is, he knew the legal act and judicial practice, but did not know the information contained in the special literature or information contained in other sources. However, as a result, his response should be based on at least two basic sources.
- **61-70 points (satisfactorily)** presented to a student who did not provide a comprehensive detailed answer to the questions of control tasks and which is based only on one of the recommended sources of studying the material.
- **51-60 points (enough)** is presented to a student who did not give a comprehensive (sufficient) answer to the questions of control tasks and can not name the source of information of the discipline.
- **0-50 points (unsatisfactorily)** exhibited to a student who revealed significant gaps in the knowledge of the basic educational material, made fundamental mistakes in the implementation of the tasks provided for by the program, unfamiliar with the basic legal literature on discipline.
