Dear scientific community, practical workers, everyone who is interested in the problems of intellectual property!

The Department of Intellectual Property, Information and Corporate Law of the Ivan Franko National University of Lviv at the Research Institute of Intellectual Property of the National Academy of Legal Sciences of Ukraine invites you to participate in the SEVENTH All-Ukrainian scientific and practical conference, the purpose of which is the accumulation, development and promotion of creative ideas and opinions, concepts aimed at improving the current legislation of Ukraine in the field of *intellectual property, information law, Internet law and IT law*.

The conference "**CURRENT PROBLEMS OF INTELLECTUAL, INFORMATIONAL, INTERNET LAW AND IT LAW**" will be held on **May 25, 2023** in online format. The link will be sent to the participants before the start of the conference.

Scientists, teachers, graduate students, adjuncts, graduates of higher educational institutions of Ukraine and other countries, judges, lawyers and all other persons interested in intellectual law issues are invited to participate in the conference.

Before the conference, it is planned to **publish a collection of abstracts** of conference participants' reports in electronic format.

Participation in the conference is **free**.

TOPICS OF THE CONFERENCE:

– **INTELLECTUAL PROPERTY:** *general theoretical problems of intellectual law; copyright, related rights; patent law; means of individualization of participants in civil turnover; trademarks; results of breeding achievements; results of creative activity with local novelty (know-how, innovative proposal); protection intellectual property rights; agreements in the field of intellectual law; taxation of intellectual property objects; customs clearance of goods containing objects of intellectual property rights; other;*

– **INFORMATION RIGHTS:** *right to information (private and public aspects); legal principles of mass media activity; legal status of journalists; legal principles of access to public information; right to privacy, etc.*

– **IT LAW:** *legal relations in the digital environment; Internet - a site as an object of intellectual property; electronic documents and electronic document flow; electronic digital signature; electronic commerce; electronic money; legal regulation of the use of cryptocurrencies; copyright and related rights in the digital environment; computer program and database as objects of legal protection; free public licenses; protection of industrial property rights in the digital environment; protection of rights to commercial designations in the digital environment; domain names and domain disputes; contractual obligations in the digital environment;*

– **INTERNET LAW:** *concepts, signs of Internet law, legal regulation of Internet legal relations, the right to access the Internet, exercising rights on the Internet, legal relations on the Internet, subjects of Internet legal relations, cybercrime and methods of combating it.*

– **PROCEDURAL ASPECTS OF CONSIDERATION OF INTELLECTUAL PROPERTY CASES AND FORENSIC EXAMINATIONS:** *procedural features of resolving disputes related to the protection of intellectual property rights, features of conducting forensic examinations.*

– **UNFAIR COMPETITION:** *protection of rights to commercial designations, rights to commercial secrets, activities of the Antimonopoly Committee of Ukraine, etc.*

– **FORENSIC EXPERTISE IN THE FIELD OF INTELLECTUAL PROPERTY, INFORMATION AND IT.**

The following should also be added to the application: for the reports of teachers who do not have a scientific degree, postgraduate students and candidates - an extract from the minutes of the department meeting on the *recommendation* of theses for publication and/or a review by a scientific supervisor who has a scientific degree.

Based on the results of the conference, a collection of conference materials will be created in electronic format.

The working language of the conference is Ukrainian.

Requirements for the preparation of abstracts of reports (messages)

volume – up to six pages in A4 format,

book orientation ;

fields - by 20 mm;

font – Times New Roman, point – 14, line spacing – 1.5, style – Normal;

the first line – the surname and initials of the author (bold italic font, aligned in the center);

the second line - place of work or study, position, scientific degree (italic font, aligned to the center), academic title;

the next paragraph is the title of the report (bold italic font, centered);

the next paragraph is the text of the abstracts of the report.

References to sources are in accordance with the existing bibliographic description (last name and initials of authors, full titles of works, city, year of publication, publisher, cited page number, etc.).

The file must be saved in Microsoft Word.

The electronic version of each document (application, theses) must have a name that corresponds to the author's surname and first name.
